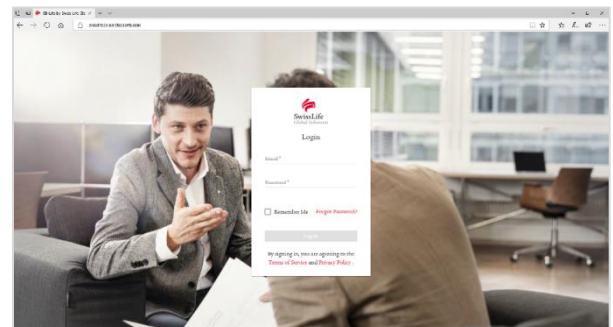

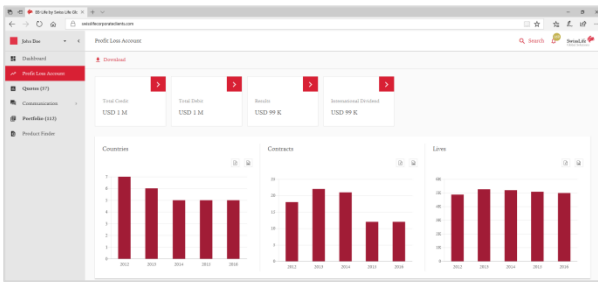

Profit & Loss clarity

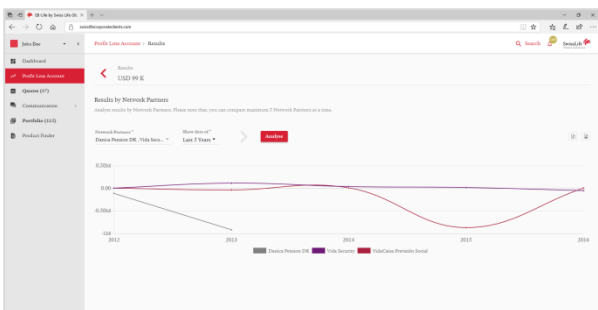
This section allows you to get a clear overview of your current international profit & loss account as well as its development over the past 10 years. Additionally, the latest international profit & loss account can also be downloaded as pdf-file for your further reference.



To get a detailed breakdown, select one of the four key sections:

- Select **<Total Credit>** if you are interested in the premium paid or in the number of employees insured.
- Start your analysis with **<Total Debit>** if your focus is on claims and the respective reserves, risk retention, commissions and expense charges.
- The **<Results>** section gives you access to the balance between the overall debits and credits of the respective accounting years and Network Partners.
- **<International Dividend>** allows you to analyse the international cash-flow, providing you with detailed information about losses which are written-off or carried forward, or about international dividends which are paid out locally.

By refining the time-frame, data-sets and Network Partners, you can access the information in a flexible and customised way. This allows you to view and analyse the data at your own convenience and in light of your own specific needs.




In short, our clear, carefully designed graphics help you gain real understanding of the data that matters for you.


You can adjust the default-values of the filters in relation to the status of the latest profit & loss account, the partners, the current general as well as the current pooling status in order to list the contracts at your convenience.

Pinpoint the contract information you need, such as premium, renewal date, effective date, broker, currency, result before pooling or coverage.

You can also add all your insurance contracts outside the Swiss Life Network to keep a full overview of your employee benefits portfolio worldwide. Those contracts can also be benchmarked at any time with the Network Partners products or the current portfolio of Swiss Life Network in the respective country.

Product finder

By using the product finder, you can locate and see the key notes for any specific product offered by partners of Swiss Life Network. Simply tick the benefits and/or country you are looking for and click on the **<Find>** button.



The percentage indicates the ratio of insured persons (for a selected country) for a coverage against the total number of persons in the portfolio of Swiss Life Network within the same industry. The top three benefits are pointed out by a star.

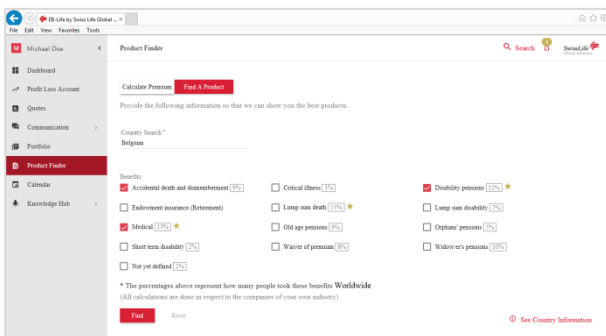
While selecting a specific product offered by a partner, you have the option to access the Employee Benefits Reference Manual (EBRM) of the market – an expert’s guide about social security, private employee benefits plans and taxation of the country.

Finding valuable country information on social security and employee benefits

By using the product finder, you can also find information on social security and employee benefits in the requested country.

Simply tick the benefits and/or country you are looking for and click on the **<Find>** button. Then click on **<See Country Information>** at the bottom right of the screen.



For the selected country, you will find the following information:

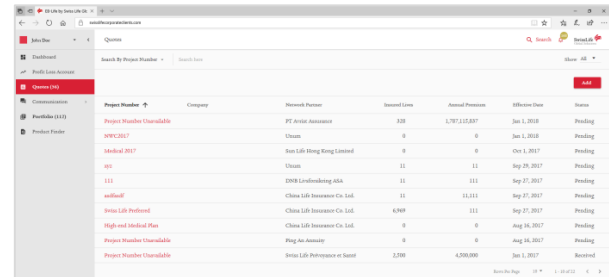
- Mandatory contributions summary
- State & compulsory benefits
- Typical employer practice.

For each type of benefit, you will find information on the benefit provider, type of plan, eligibility, waiting period, payment period, contributions...

Following quotes

This section allows headquarters to get a clear

Current ongoing local projects – even before a quote has been issued yet – can be consulted and followed here.

You can also directly contact your dedicated Relationship Manager regarding a specific project in the Quotes section to get more information.

Fine-tuned communication

You can get answers to your questions directly from the right specialist via EB-Life, whether it is specific to a unique contract or something more general:

- specific project or quote-related questions via the Quotes section
- contract-related questions via the Portfolio section
- general topics via the Communication section.

Once you have opened a dialogue, you can continue your conversation via email. EB-Life will automatically track and save all information at the point where you started, offering you the benefit to follow and collate all your communications at the relevant place without having to hunt down email trails.
